The SolarCenter Hamburg is an intersectoral, neutral counseling institution. It is a project of the Ministry for Urban Development and Environment Hamburg. Cooperation partners are the Centre for Energy, Water and Environmental Technology (ZEWU), Chamber of Crafts in Hamburg and the German Solar Energy Society (DGS).

Among others, the SolarCenter Hamburg provides free basic information on thermal heat systems, solar electricity and biogas plants for house owners and investors and provides individual counseling. In addition, the center organizes regular expert meetings for craftsmen and planners in order to promote the exchange on solar topics. They support craftsmen and planners with simulation programmes, which calculate different planning options.

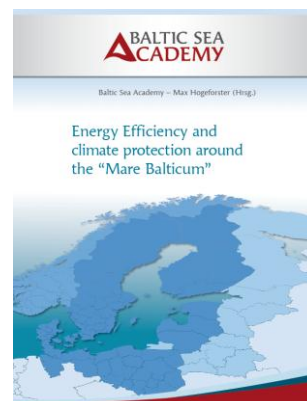

listed. The Best Practices include examples in the fields of vocational trainings, further trainings, consultation, information and networking, and additional services. The manual closes with two examples of International SME-services.

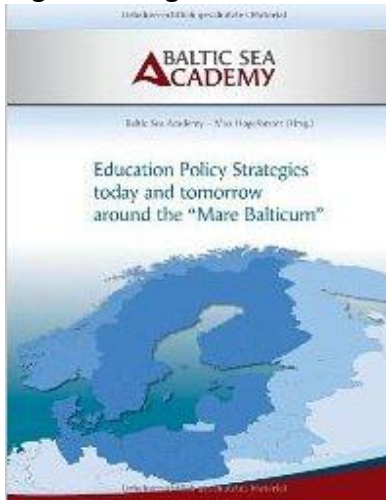

Demand for Innovation SMEs in the Baltic Sea Region

The Hanseatic Academy of Management in Słupsk/Poland and Dr. Magdalena Olczyk, Gdańsk University of Technology have conducted an empirical study on the actual demand for innovation of SMEs in the Baltic Sea Region. Between March and April 2011 542 enterprises from 9 Baltic Sea states were surveyed, primarily from Poland. The results of this study will be published in the BSA series. The study can be used to formulate recommendations aiming an increasing innovation and competitiveness of SMEs in the Baltic Sea region.

Construction Cluster Study

Within the QUICK project A. Banaitis, R. Ginevičius, A. Kaklauskas, J. Šimkūnaitė and V. Matvejevas have conducted a cluster study on the construction sector in the Baltic Sea region.

The construction cluster is strategically important for Europe and BSR providing buildings (schools, hospitals, offices, housing, etc.) and infrastructure on which all sectors of the economy depend. It is the biggest sectoral employer and a major contributor to Gross Capital Formation in Europe and BSR.

44.6 million worker in the EU depend, directly or indirectly, on the construction sector. It represents 9.9% of EU GDP and 51.4% of gross fixed capital formation. Estimated construction investment (EU 27 – 2009): 1,173 billion EUR, 3 million enterprises (EU 27), of which 95% are SMEs with fewer than 20 and 93% with fewer than 10 operatives, 14.9 million operatives: 7.1% of Europe`s total employment and 29.1 % of industrial employment. Public infrastructure investments represent between 0.5 and 2% of



GDP in European countries. 40-45% of Europe's energy consumption stems from buildings with a further 5-10% being used in processing and transport of construction materials.

The construction sector includes the following subsectors:

- Suppliers of construction products and components (incl. wholesale);
- Site preparation, Construction of complete buildings, building installation, completion and rental of construction machinery;
- Professional services (incl. architects, engineering services, cost controllers and building control bodies).
